Lottery Permit

Lottery Permit Holder:

- The Raffle is a fundraising initiative and all proceeds raised will be used by the P & F for the resourcing of the school.

Promotion Period

- **Raffle begins:** Monday 3rd February 2020 8:30 AM AWST.
- **Final ticket sales close:** Thursday 30th April 2020 11:59 PM AWST (unless sold out prior to this time)
- **Draw date:** Friday 1st May 2020 at Mary's Mount P.S. at 9.30AM AWST.

Terms and Conditions

- Purchasers must be 18 years or older.
- Only 400 tickets at \$25 each will be sold.
- There is no limit on the number of tickets that can be purchased by each individual Purchaser (subject to the overall ticket limit of 400).
- No person is permitted to participate in the lottery until the whole purchase price of the ticket has been paid.
- Proceeds from the sale of the Raffle tickets will go towards the upgrade and development of the Mary's Mount playground.
- The winner will be notified in writing and the name of the winner will be published in the Mary's Mount newsletter, on Friday the 1st May 2020.
- Mary's Mount may use a prize winner's details for promotional purposes. By purchasing a Raffle ticket, the Purchaser agrees that if the Purchaser is a prize winner, the Purchaser will participate in reasonable media activities concerning the Raffle draw and will consent to photographs or video of the winner being used for Mary's Mount marketing and promotional activities (both in print and on the internet).

Main Draw
