#### 6. Terms Of Reference

In 2023 the P&F's governing structure will change. On 2 September 2022, the Catholic Education Commission of Western Australia approved a single model of operation for P&Fs in CEWA schools. The changes will see the P&F operate as a *committee* of Mary's Mount Primary School, governed by consistent Terms of Reference and common financial practices across all CEWA schools from January 2023. The new Terms of Reference we will be voting on today replace the current MMPS P&F Constitution.

Dr Debra Sayce, Executive Director CEWA has distributed a letter for all staff, parents and friends of CEWA in regard to the changes to the P&F governance in 2023 which was distributed to all families.

Since CEWA's incorporation in 2020 the Catholic Education Office has been reviewing and improving CEWA's governance structures. Following a consultation process with Catholic School Parents WA, P&F Association representatives and school leaders, the Catholic Education Commission Western Australia (CECWA) approved a single model of operation as the best way to support the work of P&Fs in CEWA schools.

By becoming a committee of the school, we are enacting the direction from CECWA.

A video was played to further explain the changes.

The new Terms of Reference and a Q&A document have been emailed several times to families over the past few weeks. Several hard copies of both documents are floating around today.

I'd now like to open it up to the room, are there any questions regarding the new Terms of Reference we are about to vote on? No questions were raised.
