## NOTES

1. Three Year Old Kindergarten Program - There are no discounts on this fee as no grants or other external funding is received for this program. 3YO Kindy fees are pro-rated based on the student's commencement date.
2. Accounts for 2024 fees will be forwarded at the beginning of Term 1 with instructions on selecting a payment plan.
3. The Building Levy is payable once only per family with students in 4YO Kindy to Year 6.
4. A direct debit facility, credit card (in person) and BPay facility are available at no extra charge.
5. There is a 24 hour, 7 days a week Student Insurance Policy Protection provided for students attending Mary's Mount Primary School. This means your child is covered for accidents outside of school hours and property.
6. Should it occur that your child/ren needs to be withdrawn from school, then one term's notice in advance in writing and forwarded to the Principal is required.
7. All School Fees need to be paid in full by the 30 November each calendar year. If at any time you are having difficulty in meeting this deadline, please contact the school to make an appointment with the Principal.

***Arrangements regarding fees will be made on an individual basis upon appointment with the Principal.***

## HEALTH CARE CARDS

A discount scheme is available to parents with a Health Care Card (HCC) or Pensioner Concession Card with the code PPS (in the parent's name) that is current to be eligible for the discount. At the beginning of the school year, cardholders will be required to complete a form to confirm eligibility, and again on expiry of the current card. Forms are available from the office and no discount will be applied until we have received the relevant paperwork for the current year.
